Proprietary test according to OECD guideline no. 404 performed on rabbit in GLP (OECD, 1998). During the initial single animal test and the confirmatory test, the test object did not cause any skin reaction in rabbits tested as erythema or edema at the application site, as observed at 1 hour, 24, 48 and 72 hours after removing the patch.

Based on the "Primary Irritation Index" of zero (0.00) observed in this study, and as defined in the evaluation criteria, DETERDEK was found not to be irritating to rabbit skin. No skin reactions were observed in this study 24, 48 and 72 hours after the patch was removed.
